Each global division of the QBE Group operates its own Foundation, enabling us to support charities in the heart of the communities in which we and our customers live and work. In the UK, the EO Foundation is registered with the UK's Charity Commission, charity number 1143828.

In addition to the four charitable initiatives, EO employees select a charity partner to focus our fundraising activities as an organisation. Our aim is to raise £100,000 each year through the two year partnership by encouraging employees to participate in challenge events such as walks, runs, climbs and even overseas treks. We also hold dress down days, cake sales and raffles as well as special event days.

For 2018/19, our employees have chosen **Alzheimer's Society** to be our charity partner in the UK, with our remaining EO offices each supporting local Alzheimer's charities.

Since the launch of the EO Foundation in 2011, together we have donated over £7.56 million (correct as at October 2018) through grants, fundraising, payroll and matching to over 400 registered charities.
